Public Open Forum:

- The hedge by the village shop in Seighford has grown over. Unsure whose responsibility it is. Action: Cllr Busby and Cllr Hodgkins to follow up and have offered to cut it back, subject to whose land it is on.
- Bin on Seighford kick about field needed.
- Seighford Airfield noise continues. Waiting for update from SBC Cllr Jack Rose.
- The hazelnut trees, near Blackhole Lane, Derrington which are owned by the County Council, have been unlawfully uprooted and removed. SCC Winnington suggested asking Diane Firkins from SCC Highways to visit with Cllr Busby in attendance and to take it from there. Action: Clerk to contact Cllr Winnington to arrange site meeting.

SCC Cllr Winnington

Commented that SCC has invested more money into getting more pot holes filled, but they will be an on-going issue through the winter months.

SBC Cllr Rose

The chair read out an email from SBC Jack Rose, which provided an update on the Drive Me site at Seighford Airfield. It stated that the SBC enforcement team have now received the noise monitoring data from the site and is now in communication with Environmental Health regarding this. Cllr Rose said he will provide an update once the investigation is complete.

Queried whether the old laptop provided during his chairmanship can be disposed of. He confirmed that all data has been wiped from it. All councillors agreed.

- 'Slow cyclists' signs now in place.
- Community Speed Watch still taking place.
- No current issues with bus service in Derrington, according to local users.
- Recently put the Gill Cox memorial signs up on the Derrington playfield with Cllr Price.

18/11/24/10

Highways, footpaths and playing field matters

• To provide an update on discussions with the Landlord over the Seighford Playfield since October's Extraordinary meeting.

No response from the Landlord on our current proposal. Cllr Busby proposed buying a piece of equipment to put on existing kick-about field that can always be removed is necessary. It was suggested the fence also needs replacing. Action: Clerk to present 3 quotes for one piece of equipment or a multi-play to include a climbing frame, including safety flooring and other preparation work to a maximum of £10k for approval at January's meeting.

• Councillors to provide an update on playing fields inspections.

The multi-play in Derrington is in disrepair and requires fixing. It was suggested that, if on-ongoing repairs are needed, to consider investing in a new one in 25/26. Employing someone on an ad-hoc basis for equipment maintenance was also discussed. Action: Clerk to revisit inspection process to ensure regular checks are being carried out.

18/11/24/11

To report on the progress made with the legal transfer of land at Seighford Village Green to the Parish Council.

The transfer is currently awaiting the final signatory to complete the handover.

18/11/24/12

To present three quotes for the repair of the bus shelter and notice board in Derrington

Cllr Busby presented 3 quotes. The quote, offered by David Vincent, was agreed at £385. Proposed by Cllr Price. Seconded by Cllr Hayward. Unanimous.

18/11/24/13

To note the resignation of Councillor Mark Turnbull and next steps to fill the vacancy.

No request for an election, so Parish Council can co-opt. Action: Clerk to send thank you card to Mark Turnbull and submit advert to local magazines and councillors so vacancy can be advertised, locally.

Appointment of Parish Council representative to Great Bridgeford Village Hall Committee.

Cllr Price proposed Cllr Burgess who agreed to take up the position. Seconded by Cllr Wilkes. Unanimous.

18/11/24/15

To note the annual, national NALC pay agreement to the Clerk backdated to 1st April 2024.

Councillors noted.

18/11/24/16

To present the findings from the Housing Needs Survey.

Cllr Hayward presented the key findings from the survey which depicted a decline in demand for affordable housing compared to the 2011 survey. However, residents across all villages expressed a need for more shops and facilities.

Great Bridgeford had a 56% response rate, but Seighford and Derrington both had a very low response rate at 10% and 6% respectively. The overall response rate for the three villages was 26%.

Cllr Price raised concerns about the low response rates in Seighford and Derrington and mentioned that only response rates over 50% are statistically valid. The Chair and councillors acknowledged this, but said we need a more user-friendly way for people to return surveys.
